INTRODUCTION

Around a thousand mayors and local leaders will come together in Paris in December to bring the voices of local and regional governments to the 21st United Nations Conference on Climate Change (COP21). The UCLG network, the Sections, Committees and partners will mobilize for these events.

In addition to the official Local and Regional Leaders Delegation to COP21, the gathering will see a **Climate Summit for Local Leaders**, meetings of the **UCLG World Council and Executive Bureau**, and sessions on how to cooperate to tackle climate change, the role of local governments in tackling climate change, and **women's leadership and development**, among others.

We who work at local level know well that tackling climate change is not about technical solutions but making choices about the type of development model we need. It's also about learning to adapt to environmental challenges, and developing sound governance mechanisms to put citizens' needs at the heart of all we do.

The strong presence of local and regional governments at COP21 is important to showcase the huge potential of our constituency to implement practical solutions to mitigate and adapt to climate change, as well as to foster sustainable development with a strong social dimension based on citizen participation.

THE ROAD TO PARIS: LOCAL AND REGIONAL

2007

Local Government Climate Roadmap adopted by local and regional government networks. This broad coalition aims to ensure that a strong and ambitious global climate regime is designed and implemented for the post-Kyoto framework.

2010

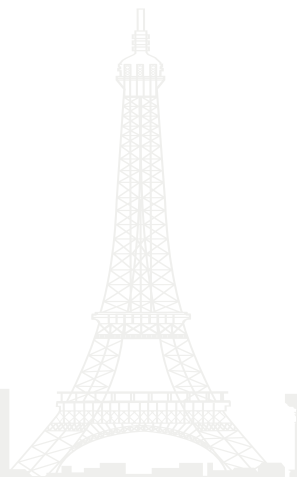
Signature of the Global Cities Covenant on Climate or “**Mexico City Pact**”. This demonstrated local leaders’ commitment to far-reaching strategies to mitigate emissions and to adapt cities to the impacts of climate change.

Local governments launch the **carbonn Cities Climate Registry (cCCR)**, a database to track measurable, reportable and verifiable climate action. This global reporting platform enables cities and local governments to demonstrate their power and potential to reduce climate risks.

2013

World Mayors Summit on Climate Change in Nantes adopts the **Nantes Declaration of Mayors and Subnational Leaders on Climate Change**, reaffirming local and regional governments’ commitments to scale up climate actions, engage at global level on climate change, and enhance local access to finance.

At the COP16 climate negotiations in Cancun, UN Member States recognize the role of local governments as “governmental stakeholders” in fighting climate change.



GOVERNMENTS IN ACTION

2014

Compact of Mayors launched at UN Climate Summit. The Compact is the largest initiative of cities to combat climate change. It commits signatories to reduce greenhouse gas emissions significantly, make existing targets and plans public, and report on their progress annually. They can apply through the carbonn Cities Climate Registry (cCCR).

The Compact of Mayors uses the carbonn Cities Climate Registry for reporting.

Representatives of civil society groups and local and regional governments from all over the world met in Lyon in July 2015 for the **World Summit Climate and Territories**.

The **Lyon Declaration** commits all major global networks of local governments to support their members to reduce greenhouse gas emissions between 2020 and 2050, in line with the international community's aim to limit the increase in global average temperature below 2°C.

The Declaration made concrete proposals for the COP21 negotiations, in particular to facilitate local and regional government access to green climate funds.

The local and regional delegation at COP21 will advocate for the current text to be maintained in the final agreement, including the preamble paragraph recognizing "the important role that subnational and local authorities, as well as non-state actors, play in addressing climate change".

The **21st United Nations Conference on Climate Change**, or COP21, will be held from November the 30th to December the 11th, 2015 on the Paris-Le Bourget site.

The decisions of the conference will be crucial to global sustainability over the coming years, as it aims to achieve the first legally binding and universal agreement that will enable us to combat climate change effectively and boost the transition towards resilient, low-carbon societies and economies.

To achieve this, the agreement must focus equally on mitigation - that is, efforts to reduce greenhouse gas emissions in order to limit global warming to below 2°C - and societies' adaptation to existing climate changes. The agreement

will enter into force in 2020 and will need to be sustainable to enable long-term change.

COP21 is one of the largest climate conferences ever organized. The event is expected to attract close to 50,000 participants including 25,000 official delegates representing national and subnational governments, intergovernmental organizations, UN agencies, NGOs and civil society.

While non-state actors' access to the conference is limited, the local and regional government delegation will follow the daily discussions among Member States and advocate through bilateral meetings and speaking slots given to Local Authorities and Municipal Governments (LAMG) in the plenary sessions.

The Action Days are multistakeholder events to follow up on the creation of the NAZCA Portal (Non-State Actor Zone for Climate Action). They aim to ensure that all stakeholders are taken into account in the climate change agenda.

The Action Days will include thematic events on different issues and events directed at specific constituencies, including local authorities.

This seminar on the Right to the City is organized by the **UCLG Committee on Social Inclusion, Participatory Democracy and Human Rights (CISDP)**, Plaine Commune, the UCLG World Secretariat and **the Global Platform for the Right to the City**. The UCLG Committees on Culture, Peripheral Cities and Local Finance will also participate.

Over the past year, the UCLG Committee on Social Inclusion, Participatory Democracy and Human Rights has been working with civil society on joint proposals to integrate the

Global Charter-Agenda for Human Rights in the City into the New Urban Agenda at Habitat III. This seminar will consolidate this alliance and explore the right to the city debate from an ecological perspective in the framework of COP21.

The debate aims to identify proposals from local governments and civil society for the Habitat III Conference. It will be held as a structured dialogue with no panel of speakers and structured around the following two questions:

1. How does climate change challenge our urban development models?
2. What issues do our cities want to raise at Habitat III regarding climate change?

Mayor of Paris and Chair of the Standing Committee on Gender Equality of UCLG, Anne Hidalgo, invites UCLG members, local elected women and partners to a special event on **Women Leadership and Development**.

The event will be held in the framework of the UCLG World Council and the COP21, also being held in Paris in December. It will bring together elected officials, local government practitioners and associations as well as key partners in UCLG's work on gender.

Local and regional governments have a long track record of working internationally for gender equality, with a particular focus on increasing the representation of local elected women and the promoting the participation of all women in local decision-making. The aim of the event is to discuss the role that gender equality at local level will play in the achievement of the major international development and sustainability agendas.

This issue will be debated in three panel sessions:

- **Local policies and services for equality: local support for SDG 5, local support for SDG 5, co-organised with UN Women**

The 2030 Agenda, which comes into effect in January 2016, includes a dedicated goal, SDG5, to "achieve gender equality and empower all women and girls," and has integrated gender equality into many of the other 17 goals. How can local policies be harnessed to achieve SDG5?

- **A gender sensitive agenda for Habitat III, co-organised with the Huairou Commission**

The importance of mainstreaming gender considerations across all urban policy-making is increasingly recognized but too often neglected in practice. Can Habitat III be harnessed to put gender equality at the centre of city design and governance?

- **Empowered women as the foundation of resilient societies, co-organised with C40 Cities**

Building resilient societies will be impossible without women. What assumptions and practices need to change to ensure women can contribute their priorities, skills and knowledge to a more sustainable future?

Environmental, social and economic disparities are strong and cumulative in high-density disadvantaged suburbs. The need for a new development model face to climate change is both an opportunity and a priority to improve living conditions in those territories. The purpose of this side-event is to identify actions and messages which could be shared by the less affluent suburbs to foster the transition towards resilient and inclusive cities.
